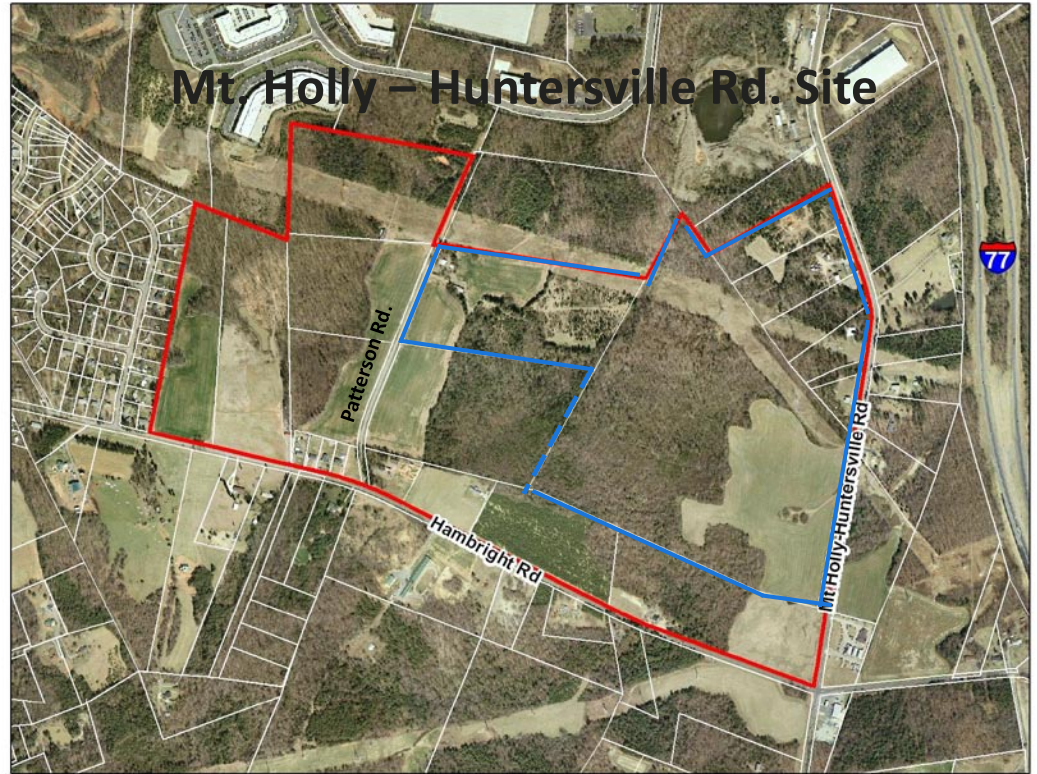

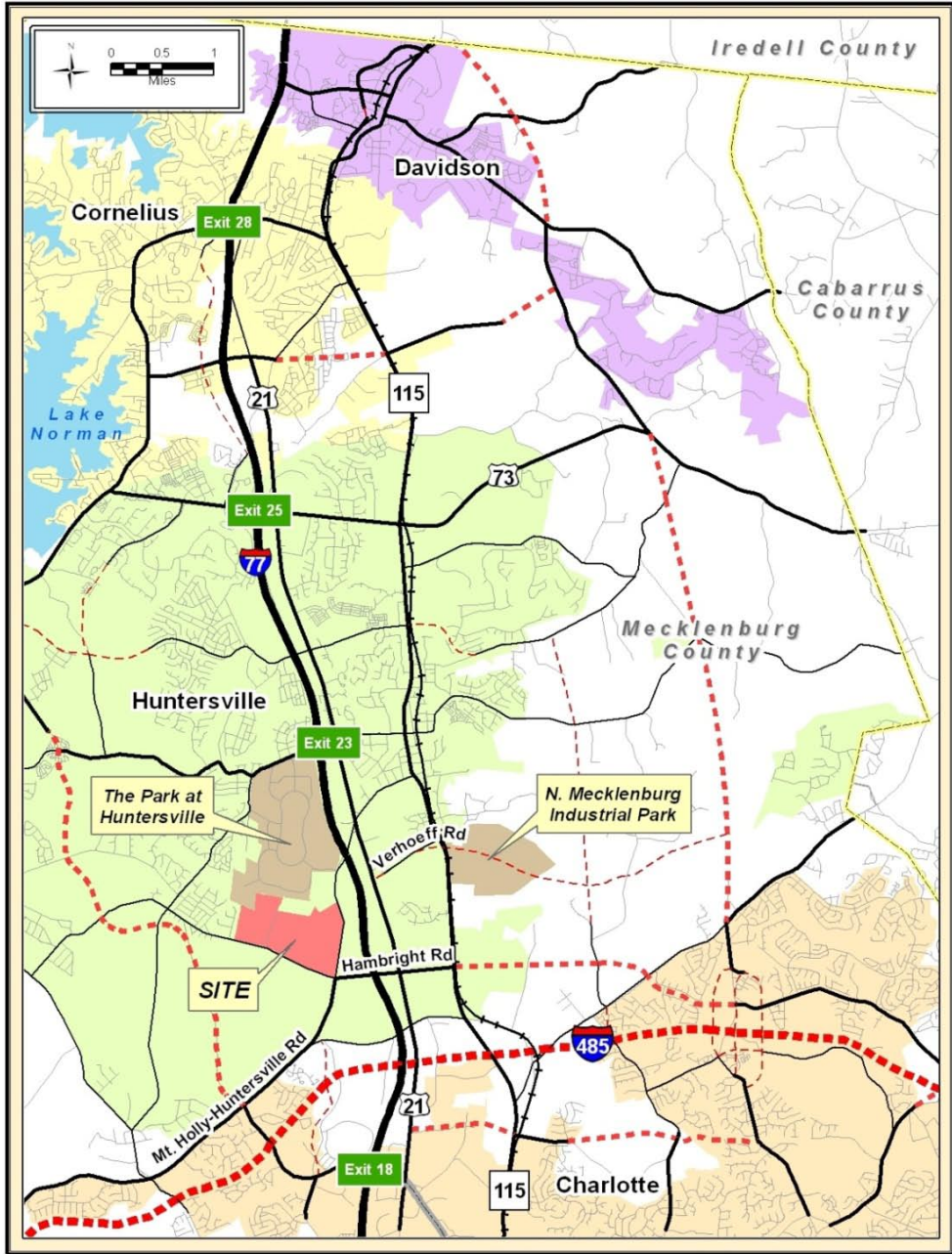
ADDITIONAL INFORMATION

The Mt. Holly-Huntersville Rd. site is located in Northern Mecklenburg County near Lake Norman just 1.5 miles from I-77 and only 3 miles from I-485. This site is part of a 350-acre future business park and is south of and adjacent to the 600-acre Park at Huntersville. Sewer is located approximately 3,100' to the west of this property and water is on Mt. Holly- Huntersville Road in front of the site. The terrain is flat to gently rolling with open and wooded areas. The Town of Huntersville zoned the property CB (Corporate Business), which will accommodate manufacturing as well as corporate office uses.
